

Gary Revel - Jongleur Pictures LLC Non-Disclosure Agreement

This Non-Disclosure and Confidentiality Agreement (Agreement) is entered into between Gary Revel - Jongleur Pictures LLC, Jongleur Books /Jongleur Music (Company) and the undersigned individual or entity (Recipient) as a condition of participating in, being considered for, or gaining access to information related to Company's film, television, media, or investigative franchise projects, including use of the official websites as named above.

1. Purpose

Recipient may receive access to confidential, proprietary, or sensitive information relating to Company's productions, including but not limited to: scripts, treatments, storylines, investigative materials, research files, casting information, financial data, production plans, business strategies, and any non-public information concerning Company's operations, partners, or affiliates (Confidential Information), including use of the official websites.

2. Definition of Confidential Information

Confidential Information includes all written, verbal, electronic, visual, or otherwise communicated information, whether marked confidential or not, including:

- Story concepts, plot details, investigative findings, and franchise related intellectual property
- Casting discussions, talent negotiations, and internal communications
- Production budgets, financing arrangements, investor identities, and deal structures
- Private or sensitive information about individuals connected to the project

- Any information disclosed during meetings, calls, auditions, interviews, or correspondence
- Any non-public information that could cause reputational, financial, or operational harm if disclosed

Confidential Information **does not** include information that is publicly available through no fault of the Recipient.

3. Obligations of Recipient

Recipient agrees to:

1. **Maintain strict confidentiality** and not disclose, share, publish, or discuss any Confidential Information with any third party without written permission from Company.
2. **Use Confidential Information solely** for the purpose of evaluating or participating in Company's production or business activities.
3. **Refrain from recording, copying, photographing, or distributing** any materials, including scripts, documents, images, or on-set content, without explicit written authorization.
4. **Protect all materials** with reasonable security measures and immediately report any suspected breach.
5. **Avoid posting, hinting, or referencing Confidential Information** on social media, blogs, interviews, or public forums.
6. **Refrain from exploiting Confidential Information** for personal, financial, or professional gain outside the scope of authorized work.

4. Non-Circumvention

Recipient agrees not to bypass, compete with, or undermine Company's business relationships, financing arrangements, talent negotiations, or investigative partnerships. This includes:

- Approaching financiers, talent, or partners introduced by Company
- Attempting to replicate, adapt, or develop competing projects based on Confidential Information

- Using Company's investigative materials or storylines for independent projects

5. Ownership

All Confidential Information remains the exclusive property of Jongleur Pictures LLC. No rights, licenses, or interests are granted to Recipient except as expressly stated.

6. Duration

Recipient's obligations under this Agreement:

- Begin immediately upon receipt of any Confidential Information
- Continue **indefinitely**, including after the conclusion of employment, engagement, or discussions
- Survive termination of any relationship with Company

7. Remedies

Recipient acknowledges that unauthorized disclosure or misuse of Confidential Information may cause **irreparable harm** to Company, including financial loss, reputational damage, and harm to ongoing investigations or productions.

Company is entitled to:

- Injunctive relief
- Monetary damages
- Recovery of legal fees
- Any other remedies available under law

8. No Guarantee of Employment or Engagement

This Agreement does not obligate Company to hire, cast, contract, or otherwise engage Recipient.

9. Legal Compliance

Recipient agrees to comply with all applicable laws and acknowledges that:

- No individual is exempt from legal or ethical accountability
- No 'star power', reputation, or status overrides this Agreement
- Violations may result in legal action and termination of involvement

10. Entire Agreement

This Agreement constitutes the full understanding between the parties regarding confidentiality and supersedes all prior discussions or representations.

Note: Email Agreement. Individuals may agree by email. When received by email, read, and replied to with 'I agree' it is officially agreed to in lieu of written signature agreement.

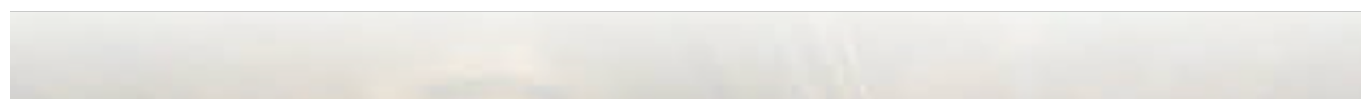
